

## FACTS WHAT DO BLB&B ADVISORS and BLBB PLAN SERVICES DO WITH YOUR PERSONAL INFORMATION?

### WHY?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### WHAT?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and Income
- Account Balances and Transaction History
- Assets and Employment History

When you are *no longer* our customer, we continue to share your information as described in this notice.

### HOW?

All financial companies need to share customer information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information, the reasons BLB&B Advisors and BLBB Plan Services choose to share, and whether you can limit this sharing.

## What we do

## How does BLBB Advisors and BLBB Plan Services protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

## How does BLB&amp;B Advisors and BLBB Plan Services collect my personal information?

We collect your personal information, for example, when you:

- open an account or deposit money
- seek advice about your investments
- provide employment information or show your drivers' license

## Why can't I limit all sharing?

Federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes – information about your creditworthiness
- affiliates from using your information to market to you
- sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

## Definitions

## Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial.

*Our affiliates include financial companies BLB&B Real Estate, LLC and BLB&B Holdings, LLC*

## Non-affiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

*BLB&B Advisors does not share with non-affiliates so they can market to you.*

## Joint Marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

*BLB&B Advisors and BLBB Plan Services do not engage in joint marketing with other nonaffiliated financial companies.*
